

# **Harvey & Verna Mohr Family Scholarship**

VISION & PURPOSE, by John Mohr, son of Harvey & Verna Mohr

This fund is being set up by John and Rebecca Mohr as a tribute to my father and mother, Harvey C. and Verna L. Mohr. Their example of generosity to the church, to education, to others and their acknowledgement that God blesses as we share those blessing helped shape my philosophy of life. So now with this endowment we wish to continue to share God's blessing to us with others.

The importance of Christian Education did not start with Harvey. It has been a priority in the Mohr Family for several generations beginning with Theodore and Julia Mohr. Their boys attended Grade school in Grandview, WA and Yakima Valley Academy in Granger, which was the predecessor of UCA. Two of the boys, Floyd and Marion, graduated from WWC and entered the ministry. Harvey went to WWC and lacked only two quarters to graduate with a degree in business, but it was war time and he was needed on the farm. The youngest, Theodore Clifford completed grade 10 and elected to farm rather than continue schooling. My mother also graduated from WWC with a secretarial degree, she later returned to complete a degree in education so she could teach in our school in Grandview.

Harvey was very involved in supporting the school in Grandview. My sister and I both attended Grandview Junior Academy through grade 10. I then went to Laurelwood Academy, graduating in 1963, my sister Janet (Mohr) Appudoray went to UCA graduating in 1964. Both of us graduated from WWC, Janet with a degree in Office Administration, I with a degree in business. My sister and I both married Christian friends we met while attending WWC (actually I met Beccie at Laurelwood).

Beccie and I both had the privilege of attending Adventist schools because our parents believed in Christian education and made it a priority. Looking back now I know that they did without things that would have made life easier for them, but they chose to send us to Adventist schools instead.

Beccie and I sent our two children to Grandview Jr Academy and to UCA, Ronda '91 and John Anthony Mohr '93. Beccie and I have seen over and over again that the friends we make in our formative years deeply impacts our lives and our relation to God. We praise God for His blessing in our own lives and the lives of our children. We do not consider Adventist education a sacrifice. Rather we consider it an investment in the future of our children's lives.
